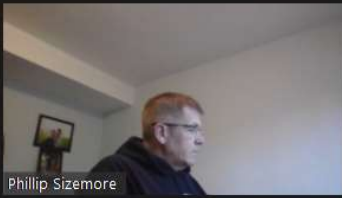

- a. Game Issues- Tripp: Reminder to be respectful and mindful of the refs and that we have field marshals on site and visible. If refs need assistance with adults they will be looking for the field marshal to assist them.
 - i. Melanie: When adults are yelling at the referee, the Field Marshal, Board Members, Should be stepping in to ensure the Refs safety. Board member preferred onsite during games to ensure logistics, and game time issues.
 - ii. Steve Gig Harbor, asked if clubs being made aware of issues during games regarding issues
 - iii. Melanie: Please provide feedback on fouls, Refs and issues so we can pass them along to Jeff in order to educate the newer refs
 - iv. Deanna SBL: If WALOA states they aren't going to officiate how does that affect the opposing team, schedule, stats, standings
 - v. Ken: Reminder that Head Coach or team captain to communicate with the Refs.
 - vi. Andrea: Peninsula, following mouth guard clarification, US LAX can't have clear or White mouth guard.

 - Kristopher: Throw all the clubs together, after week 6 of games determine brackets for SSL Tournament, A/B/C etc.
 - Phillip: Preseason tournament for placement, then breaking teams into brackets.
 - Andrea Peninsula: downstream affect, clubs wanting to change
