 - a. Review of meeting agenda and President's Report- Chris G.
 - i. Chris Gerke will be taking on the SSYL Presidents role for the 2022 Spring season due to the previous President's departure.
 - 1. Secretary to step in at VP
 - 2. In search of a new Secretary.
 - ii. Kris Conner (Treasurer) and Chris Gerke (President) are leaving after the 2022 season.
 - 1. Our children are aging out of the youth program and going into the high school. Whoever takes on the secretary role can step into another role at the end of the season.
 - iii. CLUBS TO DO-Start on your coach's background and certifications now, at least for your head coaches so you can start practices. Sometimes it takes 30 days for the background to go through.
 - iv. After team declarations are turned in, invoices will be sent to each club.
 - b. Vice President's Report-Chris G.
 - i. The rules are the same this year, especially since USL didn't update/change their rules.
 - ii. Consequences document in place now for this season. This document stemmed from emails received on Sundays after games from clubs breaking the rules. We triage the complaints then we would send a sternly worded email. There was nothing we could do about it and the same things would keep happening.
 - c. Treasurer's Report- Kris C.

- d. Club Referee Count We want 1.5 referee per declared team per club.
 - i. Chris (Orting)- Recently we had so many people yell or harass the referees so now it's hard to get referees. This isn't like other sports, where you sit courtside or sit in the stand and scream at referees. Lacrosse is a complicated sport, and the refs are doing their best. We have implanted rules to protect the referees. Head coaches are the only ones who talk to referees and the field marshals enforcing crowd management.
 - ii. Kristi (ER)- Sponsor your referees through your club by paying for their expenses like their uniform shirt, equipment, training and WALOA membership to help incentivize them because they basically have to commit and invest money before they ever get a paycheck. Years ago a lot of kids committed and never earned enough money to cover their expenses. This left a bad taste in their mouth so they talked to the incoming group. This has really stymied the pool of applicants.
 - iii. Chris (Orting)- Great idea. How much is it to sponsor a referee?
 - iv. Kristi (ER)- Between \$100-200. It is probably \$120, without the black pants and black cleats.
