    - i. All coaches need to have a lanyard to show legitimacy.
    - ii. CLUBS PRESIDENT TO DO- Sign the SSYL Compliance so that they know, understand, and verify everything is valid.
  - d. Tank Style Jersey details
    - i. Approved by WALOA.
    - ii. USL does not require numbers on both sides. The jersey will need to have a number on at least one side, front or back.
  - e. Year End Tourney Conflict Discussion
    - i. Conflict when select ball begins. We decided to move the season up a week and have Memorial Day weekend off. Clubs may be losing 6-8 players on a team if they choose to go to a select tournament instead of the End of the Year Tournament. This may also affect your tournament standings if 6-8

players are not there. We could reinstate the Memorial Day weekend and end the season one week earlier. We could just drop one game and have 7 games with the end of the year tournament.

- 1. Brian (Peninsula)- Some coaches may have kids on the select team and some select teams start at the beginning of June.
- 2. Mark F. (Hornets)- We will be able to look at the statistics of the team standings when looking at the team determination forms.
- 3. Rowdy (Bethel)- We should focus on the 8 games and drop the tournament this year.
- 4. Chris G. (Orting) -I agree with Rowdy. We could get fined or in trouble for even hosting the tournament. We could do a "challenge" for the first or second seed teams after the 8 games.
  - a. Erik Tahoma- I like the challenge weekend idea on the ending dates. Almost half of our team will be gone for that tournament.
- 5. Drew (Tacoma)- on the 26<sup>th</sup>, half my team will be gone so I wouldn't even be able to field the team. I'm willing to do double headers if need be.
- 6. Mark C. (Hornets) it wasn't going to be one single location anyways right?
- 7. Mark F. (Hornets) Yes we were looking into 9 different locations separated by age groups.
- 8. Mason (UP)- How many coaches and organizers will be gone for tournaments. And we could ask clubs now if they will have teams.
- 9. Mark TO DO email the clubs for a vote:
  - a. Challenge- after the year end standings, first / second team could ask to challenge one another
  - b. No tournament
  - c. Move the tournament forward one weekend.
- f. Referee shortage Discussed in President's report.
- g. DeAnna (S/BL)- we have 10 players for our 5/6 team, we know we can have a swing player rule. If surrounding clubs have too many players, would they be able to play for our club?
  - i. Mark- Yes, reach out to your surrounding clubs and ask them if they have a waiting list.
